I, MARY-LOUISE HRIBAL, CHIEF MAGISTRATE in and for the State of South Australia, pursuant to Section 16(3) of the *Magistrates Court Act 1991 (SA)* and Rule 13.3 of the Joint Criminal Rules 2022 and Rule 14.3 of the Uniform Civil Rules 2020, issue this Direction:

**Yalata Anangu Court sitting at Yalata**


**Narungga Court sitting at Maitland**

- 4) Magistrates Court sittings shall be between the hours of 9.30 am and 4.30 pm or at such other times as are practical.
- 5) A Registry of the Court must be open between the hours of 9 am and 5 pm on any business day, not being a public holiday, except where exceptional circumstances exist and the approval of the Principal Registrar, Magistrates Court, or in the absence of the Principal Registrar, the Registry Services Manager has been given.
